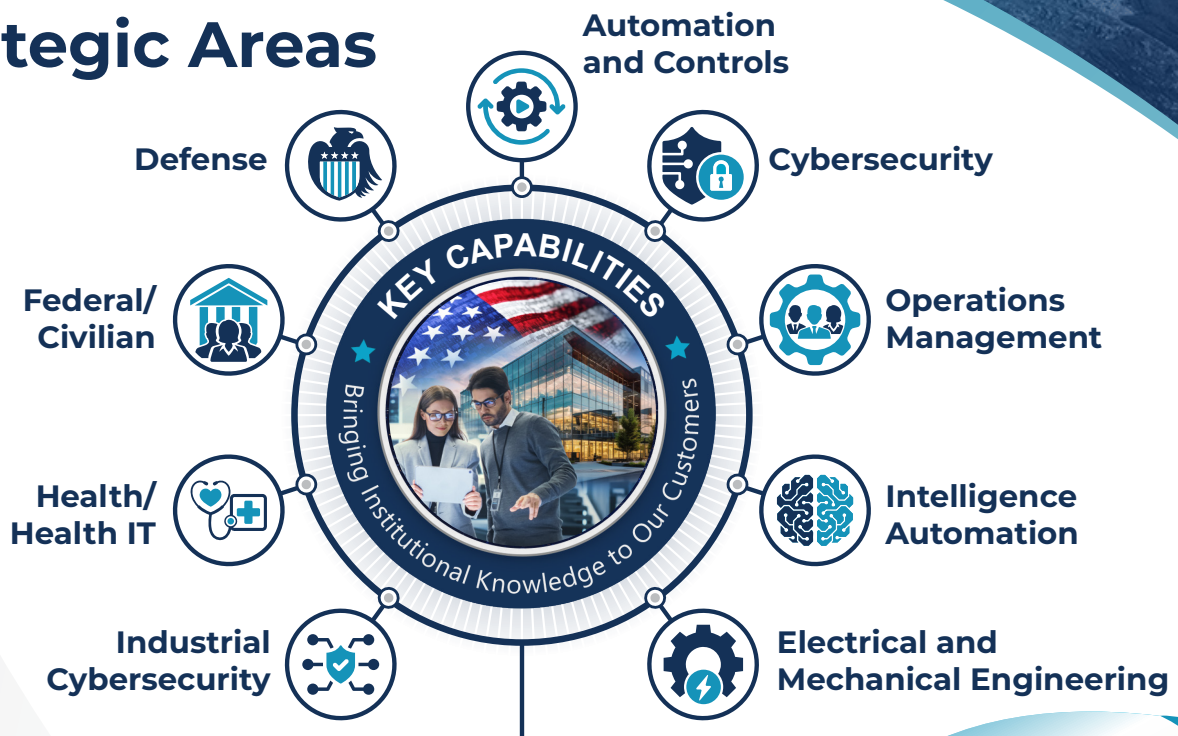

Available through all SBA-certified 8(a) subsidiaries within the KGS family of companies, direct award contracting with KGS provides the Government with Federal Acquisition Regulation (FAR) and Code of Federal Regulations (CFR) provisioned methods to maximize performance flexibility, mission continuity, and small business goal achievement.

Under federal law, Koniag, Inc. and its subsidiaries, joint ventures, and partnerships are designated “minority and economically disadvantaged business enterprises.” The 8(a) advantage provides a simplified and accelerated acquisition process.
